### I. (7:00-7:05) Introductions and Announcements

Chair recognized Roger Marenco (MUNI Operators Local 250-A): Discussion: Has SFMTA projects (red carpet lanes, etc) been helpful to MUNI divers? No. Lane restrictions etc. not enforced – LIFT and UBER move along at-will. SFMTA imposes the same plan everywhere - downtown traffic patterns are different than here in Sunset. SFMTA spends a ton of money, money spent on PR and other frivolous projects (MUINI uniforms, etc.) SFMTA MUNI acts as The City's circulatory system, transporting people that Uber or Lift could not accommodate should it shut down, go on strike. Roger invited to come back.

MISSION: We connect San Francisco through a safe, equitable, and sustainable transportation system. Vision statements are an organization's future desired state, and mission statements describe an organization's overall purpose and function. To this end, the SFMTA vision statement has been refined from the last Strategic Plan to focus on the diverse transportation options available within San Francisco. The mission statement has also been modified from the last plan to emphasize the agency's core purpose rather than a list of the specific job duties its staff fulfils on a day-to-day basis.

The intent and meaning of agency's vision and mission statement remain consistent with those established in the last plan, and will continue to aid the agency in leading and managing the city's transportation network. They resonate with staff across the agency, and are consistent with the expectations of agency stakeholders in fulfilling the agency's commitment to serving residents, workers, and visitors to San Francisco. Taken together, they set a path for the agency and guide the establishment of this plan's goals and objectives.)

# II. (7:05-7:20) Skip Scooters Presentation

Lead: Muriel McDonald, Director of Public Affairs for SKIP Scooters

Topic: Based I n SF source of its founding. Flyers passed out showing protocols of SKIP. Kick scooter rather than a moped. Serves that first and last mile of transport needs. Not trying to replace cars. Permit now allows 640 scooters as differenced from the 40K Uber vehicles in The City. Taraval is not in current service area, yet a stray scooter may appear. At the end 6 month, double scooters, at end of year trial period, we hope to be permanent. Open to dialog with communities. Cost: \$1 to unlock (.50 Low Income), .15 per minute (.07 Low Income). Wide demographic. Cannot ride on sidewalks: 3 Basic rule of the road: 1) Ride in bike lane or the street; 2) Always wear a helmet; 3) Park responsibly in the sidewalk "furnishing zone" – Do not block the pedestrian right-of-way. Runs by GPS and speed can be controlled. 50 Employees, 50% Independent Contractors for pick-up, charging, etc. Photo of end ride. Helmets are free.

#### III. (7:20-7:50) SFMTA Discussion About Recent Open House and Construction

Topic: Discuss the results of the SFMTA Open House on 10/10/18 about street beautification and upcoming road construction on Taraval Street.

See Handout. Beautification survey results are split 50/50. Mix of trees maintained by The City. Discussion of Segment A and Segment B. Updating water and sewer which are now under tracks and will be on side thereof. Less work on area near Zoo. Bus will run during work periods. Seamless ridership between train and bus envisioned. Work hours 8 to 5. No contractors for Segment B as of yet. Work block-by-block, traffic moved to one-side. Specifics still in the words. Open house in January with construction teams available to answer questions.
